



Phantasy Arabians
STALLION SERVICE AND BOOKING CONTRACT
(Gold N Glory)

THIS AGREEMENT is made and entered into this day and month written below between Phantasy Arabians ("Stallion Owner") and _____ ("Mare Owner").

THESE PARTIES AGREE AS FOLLOWS:

1. Mare Owner agrees to breed the Mare:

to Gold N Glory standing at Phantasy Arabians for the 200__ breeding season and to pay the breeding fee together with other reimbursable expenses herein.

2. The Stallion service fee shall be \$800.00. (\$400 for non-purebred Arabians) \$100.00 of which is payable at the date of the execution of this contract as a Booking Fee. This Booking Fee must be paid before the mare can be bred. **The Booking Fee serves as a non-refundable deposit.** The balance of the Stallion service fee together with all unpaid board and expenses will be paid when the Mare is picked up or before semen is shipped. Collection and shipping is Mare Owner's responsibility. Estimate will be provided in advance. The Mare will not be released to the owner or his representatives until all fees are paid to date (unless other arrangements are made in advance of the breeding with the Stallion Owner.)
3. Board shall be as follows: \$6.00 per day for the Mare alone, or \$10.00 for care of the Mare and foal. Mare care shall consist of a pen, feed and hay (as specified by the Mare Owner **ALL BOARD AND EXPENSES ON MARE AND OR FOAL SHALL BE PAID MONTHLY AND ARE DUE WHEN THE MARE IS PICKED UP.**

4. Breeder will exercise judgment consistent with recognized standards in care and supervision of Mare and/or foal. Breeder assumes responsibility for arranging veterinarian and farrier services as necessary. All veterinary expenses and all Farrier expenses will be paid by Mare Owner. **Note: Owner will be notified (if possible) before veterinarian or farrier is called.**
5. The Mare shall be in a healthy and sound breeding condition, free from infectious, contagious or transmissible disease. A current negative Coggins test, negative culture and a copy of the Mare's registration papers (both sides if applicable) plus a worming and immunization record must accompany the mare. **Breeder reserves the right to refuse Mare if not in satisfactory condition, or if she poses a threat to the Stallion. Mare must be halter broke, broke to be tied and reasonably easy to handle.**
6. Phantasy Arabians shall not be liable for injury, sickness or death of the Mare and/or her foal, regardless of how it may occur. Mare Owner shall not be liable for injury, or death to the Stallion arising out of the services contracted for in this agreement.
7. Stallion owner shall attempt with reasonable diligence to settle Mare, if, however, for any reason the Mare does not settle, Mare Owner will hold Stallion Owner and Manager harmless. The breeding season for the Stallion begins February 1 and closed July 1, at which time all breeding will be discontinued.
8. Stallion Owner guarantees a live foal from the breeding contracted for herein. Live foal is defined as a foal that stands and nurses without assistance. Should the Mare prove not to be in foal in the year bred or lose her foal, or should the foal not stand and nurse without assistance, **Mare Owner shall notify Stallion Owner in writing within one week of the foaling date (or the date the Mare is proven not to be in foal or loses her foal), such notice shall be accompanied by a written statement from a licensed veterinarian verifying that the foal is not "live" as defined above or has been lost as stated above.** Upon receipt of the specified notice, it is agreed:
 - a. Stallion Owner shall give to Mare Owner a free season to the Stallion THE FOLLOWING YEAR ONLY, and to the same mare originally booked (unless otherwise mutually agreed in writing between the Mare Owner and Stallion Owner). The Mare Owner will be responsible for the daily mare care, veterinary and farrier expenses;
 - b. If Mare Owner fails to deliver the Mare (or a substitute mare, if mutually agreed as stated above) for rebreeding the following year, then the right to rebreed is hereby cancelled and Stallion Owner is released from any further obligation whatsoever.
9. This contract shall not be transferable by Mare Owner without prior consent of the Stallion Owner. A breeders certificate will be issued when the Mare Owner notifies the Stallion Owner of the birth of the foal and only after payment of all bills due on the Mare has been received. This agreement constitutes the entire agreement between the parties; any amendment to or modifications of the terms of this agreement must be in writing.
10. Should it be necessary for Stallion Owner to employ an attorney to enforce any of the terms of this agreement, including collection of money owed, Mare Owner shall pay all attorney's fees, costs of suits, and other expenses reasonably related to enforcing this agreement.
